ALL WORKERS WORKING THROUGH FUTUREAXIS ARE CONSIDERED CASUAL, ELECT TO WORK WORKERS. Under the rules of the income Tax Act, you are considered to be a self-employed individual and not an employee of FutureAxis Employment Inc. Accordingly, income tax will not be withheld from payments made to you in respect of service provided by you as a temporary worker. You are nonetheless required to report for income take purposes all income received from FutureAxis Employment Inc. You are solely responsible for payment of any income tax liability you may have at the end of the year in respect of this income.

The income Tax Act DOES consider you an employee for the purpose of Canada Pension Plan (CPP) and Employment insurance (EI). CPP and EI contribution will be deducted from your pay cheque and remitted to the Canada Customs and Revenue Agency.

At the end of each year, FutureAxis Employment Inc. is required to prepare a T4 slip reporting the total amount paid to you during the year as well as all CPP and EI amounts deducted from payments made to you. The income Tax Act required that FutureAxis Employment Inc. send a copy of this T4 both to you and to the Canada Customs and Revenue agency.
